1. Image size must not exceed 8½ x 11 inches and be a minimum of 300 dpi.
2. Entries with people in the photograph must include a signed, dated photo release form for each individual in the picture. The approved Medina EC photo release forms are with the entry form.
3. A completed, typed and signed contest entry form must accompany each submission.
4. Each photograph must be submitted on a CD in either .jpg or .tiff format. No frames, borders, etc. are to be included with the photograph. Submissions will not be returned.
5. Minor digital enhancements to crop, filter and correct are permitted, but the alteration or removal of elements in the image by cloning or similar methods is not allowed. Significantly altered images will be disqualified.
6. Medina EC retains the right to use any submitted photographs for the cooperative's editorial or promotional purposes without compensation to the photographer. Photographer credit will be issued whenever an image is used.
7. All entries must be postmarked by **Monday, June 2, 2014.**
